## Winter Park 2008

On Wednesday, January 9th, four OSC members traveled to Winter Park to participate in the first club trip to that location in several years.

Teri was the first to arrive, in the early evening hours. She encountered falling snow in northeastern Colorado and blowing snow on Berthoud Pass, but made it to our lodging at the Vintage Hotel in good shape. Roberta, Steve and Ben left Omaha later in the day, encountered light rain in central Nebraska then dealt with snowy roads in northeastern Colorado and Berthoud Pass. After some delays, they got to the hotel safely later in the evening. We all checked into our condos, and then settled down for the night.



Thursday morning, the 10th, was cloudy and cold. Several inches of fluffy new snow had fallen overnight, which, together with several days of snow earlier in the week, produced excellent conditions on the slopes. We spent most of the morning skiing the intermediate areas near the Winter Park base. Roberta explored the NASTAR race course, and was awarded a platinum medal; something only the top 5% of racers get! We had

lunch at Snoasis, and watched the snow begin to fall again, then spent several more hours sampling the powder. We tried out the large hot tub visible below our rooms, and then had a welcome dinner at the Winter Park Pub in downtown Winter Park. The accumulated snow outside produced some interesting scenery!



Friday, the 11<sup>th</sup>, continued the trend of cold, snowy conditions, with lots of fresh, fluffy powder. We began by skiing together in central area of the Winter Park section, then split up. Roberta spent some more time at the NASTAR race course, Ben and Teri explored the new, advanced to expert “Eagle Wind” section of the mountain, and Steve used his skills to navigate the double-diamond bump runs near Mary Jane. We reconvened for lunch at Sunspot, and then checked out the gladed terrain under the new six-pack Panoramic Express lift. It contained lots of tree runs and deep powder- good stuff! At the end of the day, we took advantage of the hot tub, and then had nachos and beef for dinner at the hotel restaurant.



The weather on Saturday, the 12<sup>th</sup>, was sunny and dry – great for observing the scenery and taking pictures. It was Steve’s turn to explore the Eagle Wind expert runs, while Ben and Teri checked out the groomed blue-black runs on Mary Jane. At the end of the day, Steve retired to our condo to watch a Nebraska basketball game, while Ben, Teri and Roberta had a fancy German dinner at the Gasthaus Eichler restaurant in downtown Winter Park.



The following morning was partly cloudy and cold. We skied a half day on the groomed runs above the Winter Park base, and then left for Omaha. The weather cooperated for the trip back, which was much less stressful than the trip out. Great skiing!

## Three Valleys 2008

Three OSC members – Mark, Ben and Jim – participated in this season’s Chicago Metropolitan Ski Council (CMSC) Europe ski trip to Three Valleys (“Trois Vallees” in French), from Friday, January 18<sup>th</sup> to Sunday, January 26<sup>th</sup>. Three Valleys is in southeastern France (red star on map at right) near the triple point where France, Switzerland and Italy meet. The three valleys are actually three interconnected ski areas: Val Thorens, Meribel and Courchevel, each of which occupies its own valley. Each individual valley is larger than any ski area in the U.S. Together, they’re the biggest ski area in the world, with 375 miles of groomed trails. During six days of skiing, on the 20<sup>th</sup> through the 25<sup>th</sup>, we were able to sample many of them. CMSC is a group of over 80 ski clubs; 47 of their people, including three OSC skiers, were on the trip.



Getting to Three Valleys was time-consuming, involving three flights and a 3-hour bus ride. Ben and Jim began the process with a one-hour flight from Omaha to Chicago’s O’Hare airport; Mark’s initial

flight departed from Denver. Once at O’Hare, we picked up our luggage, did a bag drag from the domestic to the international terminal, then checked in again at Air France. We then got on 2 more flights; an 8-hour one from Chicago to Paris and a one-hour connecting flight from Paris to Geneva, followed by a 3-hour bus ride to the ski area and hotel in Meribel-Mottaret. Along the way, we shifted time zones; the time zone in France is 7 hours ahead of Omaha and 8 hours ahead of Colorado. The end result was worth it; great snow, six days of excellent skiing (the 20<sup>th</sup> through the 25<sup>th</sup>) and fantastic scenery. The weather on five of



the six days was dry and mild, perfect for skiing.

The size of the area we were in dictated our plans; the three valleys are too large to cover in one day, so we chose a different valley to ski in each morning. We spent much of the time skiing with a group of about 30 people led by the trip’s assistant captain, who had been to the area before and knew his way around. This was important, because the area has many base points, with few shuttles between them, and being stuck at the wrong base point at the end of the day would have led to a cumbersome and expensive cab ride back to the hotel. Fortunately, we were warned about this issue in advance and didn’t get lost.







We spent the first day, Sunday the 20<sup>th</sup>, mostly in the Courchevel valley. Conditions were excellent, but lunch was expensive – we found out later that Courchevel is France’s equivalent of Vail or Aspen. Spaghetti was 16 euros or \$24 – ouch! At least it was a fancy place. That night, and every subsequent night, we had dinner at the hotel – it was included in the price of the trip. Breakfast at the hotel was also included. That helped make up for the nasty \$1.47 to 1 euro exchange rate; we also bought very little in the local area to keep costs down.

Monday the 21<sup>st</sup> was spent in the southern part of the Val Thorens valley – we took a tram over to its extreme southern end, called Orelle, and had lunch there – cafeteria style, much cheaper. The scenery and skiing were spectacular, and the weather was great – mild, dry, no wind. We did over 25,000 feet of total vertical, went fast on lots of blue cruisers, and did a little bit of “off-piste” bump skiing. Towards the end of the afternoon, we had a nice break at a restaurant at the top of the ridge between the Val Thorens and Mirabel valleys. Fantastic view!



The weather of Tuesday, the 22<sup>nd</sup>, took a turn for the worse – foggy, snowy and windy. Many of the higher lifts were closed. So, we stayed in the Meribel valley – still got some good powder skiing, had a nice lunch at a mid-mountain restaurant. The weather cleared that night, and on Wednesday, the 23<sup>rd</sup>, it reverted back to the usual sunny and dry conditions.

We responded by exploring the northern portion of the Val Thorens valley. Once again, we did over 25,000 feet of total vertical, using every imaginable type of lift except rope tows– pomas, trams, variously sized gondolas, 2 to 6 person chairlifts. That evening, we attended the first of several parties in people’s rooms – got to indulge in lots of tasty French wine and cheese.





Thursday, the 24<sup>th</sup>, was a day to try out some bumps and skiing on non-groomed terrain. We began by checking out the bumps and watching balloons at Courchevel, then returned to the Meribel-Mottaret base near our hotel to get a relatively cheap lunch, then got over to Val Thorens to try some non-groomed terrain there. That night, we had another wine and cheese party – good stuff!

Friday, the 25<sup>th</sup>, was our last skiing day. We spread out and split up; Mark focused on bump runs, while Jim and Ben did mostly blue cruisers to finish out the trip. Once again, conditions were just about perfect. On the way back to the hotel, we got to see some people try to ski in sumo wrestling outfits – rather bizarre.



That night, we stopped by a local dance club, “Discotheque Privilege”. One of the bartenders at our hotel got us in for free. Yes, they still have discos in France. The music was strange – heavy, industrial-strength thumping – and so were the people inside. We got to see a visiting rugby team jump wildly up and down, and swing one of their people around horizontally along the floor. Definitely different. We partied there

until 2 am, got back to the hotel, had an hour nap, then got up at 3 am, had a quick early breakfast at the hotel, followed by the 4:30 am bus ride back to the Geneva airport. On the way, we dropped off 11 CMSC people at a local train station; they continued on with an optional trip extension to Milan (no skiing). The three OSC skiers got on a plane at Geneva, changed planes at Paris, and made it back to Chicago safely on Saturday afternoon. Jim and Ben got on a flight to Omaha that evening; Mark got on a flight to Denver and drove back to Colorado Springs. We all made it safe and sound, no injuries. A memorable trip!
