

Do you know....what a trip captain does?

- Make sure each signed up member has a **trip application** filled out completely
- Make sure each member is a **paid member** (this is verified with the membership chair)
- Make sure each member has their **payment to you as scheduled** (schedule is determined by when trip payments are due)
- Maintains **the emergency contact list** for members of their trip (information is on the trip applications)
- **Coordinates** air, transfers, lodging with VP Trips.
- Assigns rooming for hotel or condo pillows (**rooming list**)
- Plans and coordinates **welcome party** while on the trip (budget determined by number on trip)
- Turns in **final accounting** after trip returns (forms provided)
- **Attends board meetings and social functions** to promote the trip and update the board of numbers, payments due, problems, etc. (the more people you get, the larger the stipend you receive)
- **Writes an article for the newsletter when their trip returns**

Any member can be a trip captain. If you are interested and going to go on the trip, I can help you get started.
