Two OSC members – Mark and Ben – participated in this season's Chicago Metropolitan Ski Council (CMSC) Europe ski trip to Sölden, Austria, from Friday, January 16th to Saturday, January 24th. Sölden is in southwestern Austria (red star on map at right) in the Ötz valley, near the Italian border. The Ötz valley is also known as the place where a four thousand year old "iceman" was found several years ago, frozen in a melting glacier on the Italian side of the border. The valley contains a half-dozen ski areas, of which Sölden is the largest. During six days of skiing, on the 18th through the 23rd, we skied 5 days at Sölden and one day at two nearby smaller ski areas, Obergurgl and Hochgurgl. CMSC is a group of over 80 ski clubs; 27 of their people, including the two OSC skiers, were on the trip.





Getting to Sölden was time-consuming; we took three flights and a 4-hour bus ride. Ben began the process with a one-hour flight from Omaha to Chicago's O'Hare airport; Mark's initial flight departed from Denver. Once at O'Hare, we picked up our luggage, did a bag drag from the domestic to the international terminal, then checked in again at Air France. We then got on 2 more flights; an 8-hour flight from Chicago to Paris and a one and a half-hour connecting flight from Paris to Munich, which was followed by a 4-hour bus ride to the hotel (picture at left) in central Sölden. Along the way, we shifted time zones; the time zone in Austria is 7 hours ahead of Omaha and 8 hours ahead of Colorado. Once there, we were able to ski six days on a wide variety of terrain.

We skied one day in the nearby Hochgurgl and Obergurgl areas, and the other five days at Sölden. We did this to take advantage of the weather; the Hochgurgl and Obergurgl areas were higher up and more sensitive to bad weather, so we picked the day with the best weather to ski there. We spent most of the time skiing with a group of about 15 people led by the trip's co-captain, who had done some advance research on the area. The 27 skiers on the trip are shown at right in a group picture.



We began our first skiing day, Sunday the 18th, with a short bus ride to the lifts. We skied mostly in the lower levels of Sölden, to get acclimatized and oriented to the area. The weather was cloudy, but the visibility was good and the snow was excellent. That night, and every following night, we had dinner at the hotel – it was included in the price of the trip. Breakfast at the hotel was also included.





The following day, Monday the 19th, we became more adventurous and covered the entire Sölden area, including the glaciers at the top altitude of about 10,000 feet. We also skied the entire "big 3 rally" route, which covers all of the three mountains within the Solden area.



On Tuesday, the 20th, bad weather made an appearance – heavy snow and high winds. The higher lifts were all closed. We retreated to the lower portion of Sölden, and skied there for the rest of the day. We also spent some time inside interesting and unique on-mountain rest huts and restaurants.



Wednesday, the 21st, was very foggy. The mid-mountain runs were part pea soup, part whiteout. Conditions were challenging. We slowly found our way around, and then ended the day with Austrian party music at a bar near the base of the mountain below the fog layer. Early Wednesday evening, we attended a party in the trip leader's condo, and consumed our share of red wine, white wine, whiskey and appetizers. It helped us to forget the bad weather earlier in the day.



Thursday, the 22nd had perfect weather; dry and pleasant, with crystal clear blue skies. We spent the day at the nearby Obergurgl and Hochgurgl ski areas and took in the great snow and scenery. That evening, we stayed late at a local on-slope restaurant, then skied back to the Obergurgl base after sunset, and then caught a bus back to Sölden.

Clouds returned for our last skiing day on Friday, the 23rd. Fortunately, the snow, wind and fog stayed away. We explored Sölden one last time during, the morning, then had lunch at an old mountain hut filled with unusual old farming tools.



We then returned to the Solden base, stopping along the way for one last chance to look at the scenery.





That afternoon, we stopped at the Giggijoch midmountain restaurant area to listen to a live band's Austrian version of U.S top 40 songs. Definitely unusual - the hundreds or so people gathered near the outdoor stage enjoyed it, we did also.



Early Saturday morning, on the 24th, we left Solden and went our separate ways. Ben left with nine other people to go directly back to Chicago (and then to Omaha) by bus and plane the same way we got there. Mark left with the other 16 people to go by train to Budapest, Hungary for a two-day non-skiing extension of the trip, to investigate Hungarian culture and exotic food. Both of us made it back on time and in one piece; Ben on the 24th and Mark three days later. A good trip!

OMAHA SKI CLUB TRIP POLICIES

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times
- 3) There will be a \$28.00 charge on any returned check.

TRIP SIGN-UP, DEPOSITS AND PAYMENTS

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7). Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7).
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

CANCELLATIONS AND REFUNDS

- 7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.
- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item 7) above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

BUS TRIPS

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
- 14) The Omaha Ski Club will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they can do so at their own expense, and assume all risks and liabilities associated with such consumption.
