## *Jackson Hole Trip – March 20 to 26*



Six members of the Omaha Ski Club took an adventurous road trip to Jackson Hole WY, on Sunday, March 20th. On the way, Teri, Vance and Phil were delayed in Rawlings for an hour due to icy roads. We had breakfast and waited for the sand trucks and the morning sun to warm the roads a bit. Dave and Ben, who were an hour behind us, had to take the other route through Lander to Jackson as the interstate was closed due to three trucks in the ditch. We all arrived in Jackson safely. We had a late lunch at the Snake River Brewery and walked around town. We went into a ski shop that was going out of business to look at some skis and bikes. We checked in at the 49er and unpacked. It felt great to relax after the long drive. Mark was delayed and could not join us until Tuesday.



**Monday** morning after a hot breakfast at the hotel, we crammed 5 people in the car and drove to Jackson Hole resort. It was cloudy with low visibility but there was lots of snow. During our stay, they had received their 530<sup>th</sup> inch of snow for the season. Après ski was at a locals bar at the base where we relaxed and decided where to go for dinner. That evening when we got back, I returned to that ski shop that was going out of business and bought a new pair of Dynastar Legend Sultans. That evening we went to the Million Dollar Bar. Each of us saddled up to the bar and had a drink before dinner. Dinner was delicious. Dave and I had the buffalo with potatoes and asparagus and Teri had the elk medallions with spinach and potatoes. After dinner, I found a good ice cream shop by the north east corner of the town square. We had to have dessert.



**Tuesday** It was very windy, snowy, and foggy at Jackson Hole but we were skiing in 20 inches of new powder. It was difficult to see where we were going. We found that the Mangy Moose had the best priced drinks after skiing. Afterwards, it was off to the indoor hot tub to relax and warm up. That evening, we had a small welcome party in Phil's room with cheese, deer/beef sausage and crackers. Mark finally arrived just in time to join us for the party.



**Wednesday** was spent at beautiful Jackson Hole. We could see the mountain! It was a bright sunny day. The snow softened up to mashed potatoes at the lower altitudes so we took the tram up to the top about 11 AM. The snow up there was soft and we had fun playing in Rendezvous Bowl. After an enjoyable day, we found ourselves again at the Mangy Moose. When we went back to the hotel, we tried the outside hot tub. It was nice, but a little chilly walking across the parking lot. That evening we had a BBQ dinner at the 49'er with the Nomads ski club from the Chicago Metropolitan Ski Council (also staying at the 49'er) hosted by the hotel.



**Thursday** was our day at Grand Targhee. We got on the bus at 7:15 and took a scenic tour of Jackson moose grazing on the side of the road. Arrived Targhee about 9:30. We could see Grand Teton in the morning but after 11 it got foggy and couldn't see much of any thing except for near by trees. Stopped for an early lunch. After lunch we tried the good, the bad and the ugly. We jumped in between the



powder was good after I pulled my ski out of the deep stuff. The final run was in the fog down the gully. Mark napped on the ride home. After a few minutes in the hot tub we went to dinner at a Chinese restaurant.

We had drinks at the Mangy Moose before returning to the hotel to pack. That evening we went to Teton Steakhouse for dinner.



The town of Jackson was busy and our hotel had filled up for the busiest weekend in Jackson Hole. The snowmobile races up Snow King, the local mountain, were taking place on Saturday so all the “slednecks” as the locals call them, were in town for the event.

On Saturday morning, the 26<sup>th</sup>, we packed the vehicles and headed home. It was a good trip to end the season.
