## Copper Mountain – December 14 to 18, 2011

Nine Omaha Ski Club members arrived at the Fox Pine condos on Wednesday, December 14<sup>th</sup> to participate in several days of skiing and snowboarding at Copper Mountain. Phil, Teri, Eric and Lamont drove out from Omaha the previous evening, got there the morning of the 14<sup>th</sup> and skied (or in Eric's case, rode) at Copper on the 14<sup>th</sup>; El, Pat, Ben, Mark and Randy drove out during the day and arrived on the evening of the 14<sup>th</sup>. Some of us had a quick dinner at Endo's Adrenaline Café at the base of Copper Mountain that night. The next morning, on Thursday, the 15<sup>th</sup>, most of us walked from the condos to the nearby Super Bee lift to ski and ride. The weather was clear, dry, cool and pleasant, with light winds – a "bluebird day". These conditions would continue on Friday and Saturday. Snow conditions were good



overall, but the area of the mountain that was open was limited due to the sparse snowfall earlier in the month – bases were in the 20 to 25 inch range. We had fun on the intermediate (blue) groomed slopes with one or two excursions onto the few black mogul runs that were open. Later on Thursday afternoon, we ended the skiing day with a stop at Jack's bar to watch our favorite après-ski bar band – Lefty Lucy – play. That evening, after a quick dip in the hot tub, some of us had burgers and soup for



dinner at a different



at Copper Mountain dining establishment – Tucker's Tavern. The following morning, Friday the 16<sup>th</sup>, we explored the west side of the mountain, and skied and rode the intermediate runs near the Timberline lift and the green runs in the Union Creek area. Some of the green runs were more challenging than usual due to sparse snow cover; we dodged lots of twigs and skirted bumps and rocks. Jeff Krinsky from the Denver area joined us early Friday evening at the end of the skiing day. Later that evening, all of us had a fun welcome party/dinner at the Cowboy's Pizza Station in western Frisco. We went

through three pizzas, two orders of hot wings, several salads and a few drinks. The following morning, on Saturday the 17<sup>th</sup>, we got on the Super Bee lift outside the condos for our third and final day on the mountain. We explored all parts of Copper Mountain that were open, from the Andy's Encore and Oh No runs on the east side to Soliloquy on the west side. Later that afternoon, we finished the day with another stop at Jack's to see Lefty Lucy again, then spent some time in the condo's hot tub, followed by dinner at the Moose Jaw in Frisco. Sunday the 18<sup>th</sup> was our departure day; conditions were fine with clear, dry roads. Most of us arrived back in the Omaha area that evening. A great start to the ski season!

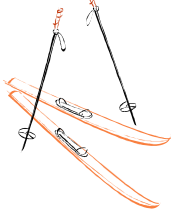

## OMAHA SKI CLUB TRIP POLICIES

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$28.00 charge on any returned check.

### TRIP SIGN-UP, DEPOSITS AND PAYMENTS

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child.
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item 7). Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item 7).
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

### CANCELLATIONS AND REFUNDS

- 7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip.
- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item 7) above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

### BUS TRIPS

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops en route to its destination, passengers leaving the bus will do so at their own risk.
- 14) The Omaha Ski Club will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they can do so at their own expense, and assume all risks and liabilities associated with such consumption.
