Last year, a group from the Omaha Ski Club participated in the annual Corporate Cycling Challenge. We'll be participating again this year. We'll be entering on an individual basis in the Open division.

The Corporate Cycling Challenge is Nebraska's largest one day bicycling event. Normally, several thousand riders participate. It starts and ends at the Heartland of America Park (8th and Farnam St) in downtown Omaha. Three different ride lengths are available - 42 miles, 25 miles and 10 miles. Mail-in registration for all of these rides is \$25 before July 24, \$35 after. Proceeds from the ride benefit the Eastern Nebraska Trails Network.
