Ruth Rahn Obituary

It is with sadness we announce the loss of a long time member of the Omaha Ski Club. Many of you remember Ruth, always a laugh and she loved her family and friends. RIP A. Prayers for her family and friends.

Ruth Vivian Rahn

Mar 7, 1931 - Aug 13, 2024

Ruth Vivian (Lucas) Rahn, age 93, of Plattsmouth, NE, passed away on Tuesday, August 13, 2024, at the Louisville Care Center. Ruth was born on March 7, 1931, to Frank Marion Kent Lucas and Eula Velma (Ricketts) Lucas in Louisville, KY. Ruth was raised on a farm in rural Xenia, OH, where she graduated from high school in 1949. Shortly after, she embarked on a path of service, enlisting in the Army in 1949 and serving until 1953 at Fort Dix in Texas during the Korean War. Ruth's time in the Army was marked not only by her regular duties but also by her involvement as an Army cheerleader and basketball player.

After her honorable discharge, Ruth pursued her passion for nursing, attending Miami Valley School of Nursing, where she graduated in 1957. She worked locally, continuing her nursing residency until she felt the call to serve her country once again. In 1965, she joined the Air Force as a Flight Nurse, a role she proudly fulfilled at various bases:

1965 - 1967: Incirlik AFB, Adana, Turkey - Flight Nurse

1967 - 1970: March AFB, Riverside, California - Flight Nurse

1970 - 1974: K.I. Sawyer AFB, Marquette, Michigan - Flight Nurse

After being honorably discharged from the Air Force as a Captain in 1973, Ruth focused on homemaking while following her husband's career:

1974 - 1979: Bitburg AFB, Sülm, Germany - Homemaker

1979 - 1981: Castle AFB, Merced, California - Nurse

1981 - 1983: HO TUSLOG, Ankara, Turkey - Homemaker

In 1983, Ruth and her family settled at Offutt AFB in Plattsmouth, Nebraska, where she continued her nursing career until her retirement.

On August 31, 1971, Ruth married the love of her life, Larry Brian Rahn, whom she met at K.I. Sawyer AFB in Marquette, Michigan. Their union was blessed with two daughters, Anastasia Roby and Becky Alexander. Ruth is survived by her husband, Larry Rahn of Plattsmouth, NE; her daughters, Anastasia Roby and her husband Jamison "Jamie" of Plattsmouth, NE, and Becky Alexander and her husband Heath of Bellevue, NE; three grandchildren, Nicholas Rahn, Alexander Roby, and Nataliya Roby; one great-grandson, Damian Rahn; and many friends. She was preceded in death by her parents, Frank and Eula Lucas, and her siblings, Jack Lucas, Audrey Bann, and Dorothy Beach.

Ruth was a dedicated member of the Plattsmouth Rotary Club for more than 26 years, achieving perfect attendance for 23 of those years. She was also an active member of the Omaha Ski Club, skiing into her late seventies with her grandson Nicholas. When she wasn't skiing or attending Rotary meetings, Ruth loved tending to her plants, a gift she passed down to one of her children. She was also a member of the Dancing Grannies and was a devoted grandparent when she wasn't working night shifts. Ruth had a deep love for animals, having had numerous cats and dogs throughout her lifetime.

A Visitation will be held from 4:00 PM to 8:00 PM on Friday, August 23, 2024, at Roby Funeral Home in Plattsmouth, NE.

A Memorial Service will take place at 10:30 AM on Saturday, August 24, 2024, at Roby Funeral Home with Pastor Michael McGregor officiating. A funeral luncheon will follow immediately at Harald Hall.

Her final resting place will be at the Omaha National Cemetery in Omaha, NE, at a later date.

- Seven nights lodging at the beautiful Mountain Lodge at 457 Mountain Village. Lodging consists of 2-bedroom suites, 2bed/2bath condos and two 4-bedroom cabins. Lodging assigned on a first signed up basis. Ski-in, ski-out, outdoor hot tubs and heated pool, Free Wi-Fi, fitness center and sauna, ski storage lockers, free shuttle to Gondola, Mountain Village Market, and Mountain Village. Arrive on Saturday, check-out on the following Saturday morning. Check-in 4 PM, check-out 10 AM

OMAHA SKI CLUB TRIP POLICIES

- 1) Trip captain is the final authority on and during the trip.
- 2) Club members will conduct themselves in a mature manner at all times.
- 3) There will be a \$28.00 charge (subject to change according to bank fees) on any returned check.

TRIP SIGN-UP, DEPOSITS AND PAYMENTS

- 4) Only members in good standing with dues currently paid to the Omaha Ski Club may sign up for a trip. Children under the age of 19 must be accompanied by a parent or guardian on the trip. A trip application for a child under the age of 19 must be signed by a parent or guardian of the child
- 5) By signing up for a trip a member agrees to pay the Club the full cost of the trip applied for, subject to the provisions for timely cancellation in item #7. Each trip will have its own trip deposit and payment schedule to be set by the trip committee. A deposit is required to sign up for a trip. Failure to meet the payment schedule may result in automatic cancellation from the trip subject to the cancellation fee in item #7.
- 6) When a trip is full the trip captain will start a waiting list. To be placed on the waiting list a member must fill out and sign a trip application and pay the standard deposit for that trip. Waiting list members must meet the payment schedules when moving to the confirmed lists.

CANCELLATIONS AND REFUNDS

7) Unless otherwise listed in individual trip information, cancellations prior to 60 days before the trip departs will result in a cancellation fee of \$50.00; cancellations less than 60 days before the trip departs will result in a cancellation fee of \$100.00 if the trip goes full, or liability for the full cost of the trip if the trip does not go full. Any cancellation fees or penalties may first be deducted from payments the member made for the trip. Medical cancellations will be reviewed by the Board for refund determination.

- 8) Transferring from the waiting list on one trip to a confirmed list on another trip will be done with no cancellation fee. Refusal to move from the waiting list to the confirmed list will constitute automatic cancellation subject to the cancellation fee in item #7 above.
- 9) If a trip is cancelled by the club, all money paid to the club by a member for that trip will be refunded.
- 10) All members on the waiting list when the trip departs will receive a full refund.
- 11) No refunds will be made until after the trip returns.

BUS TRIPS

- 12) Smoking on buses is prohibited.
- 13) Any time the bus stops enroute to its destination, passengers leaving the bus will do so at their own risk.
- 14) The Omaha Ski Club will not provide alcoholic beverages for any bus trip. If any members wish to consume alcoholic beverages on the trip, they can do so at their own expense, and assume all risks and liabilities associated with such consumption.
